Named in 1953, the "Sunshine Mile" is the section of Broadway from Euclid (just east of downtown) to County Club. It has been the subject of the Broadway widening debate, which, at one point, would have demolished 37 merchants within the Rio Nuevo District. The new alignment preserves many of those merchants. The Sunshine Mile merchants are interested in revitalizing the area as a mid-century modern destination and seek designation as an historical site.

The Sunshine Mile was a go-to destination for young Tucson and the home of many iconic establishments from Broadway Village, Tucson's first suburban shopping center designed by Josias Joesler in 1939, to the Bernard Freidman designed Valley National Bank at County Club built in 1971. These boulevard shops and buildings, built between 1945 and 1970, are significant architecturally and could be a destination not unlike downtown, rich with heritage and increased sales.

After hearing presentations on this subject, the Board will discuss and may vote to take action in connection with revitalizing the Sunshine Mile. which may include directions to staff and/or counsel.
