



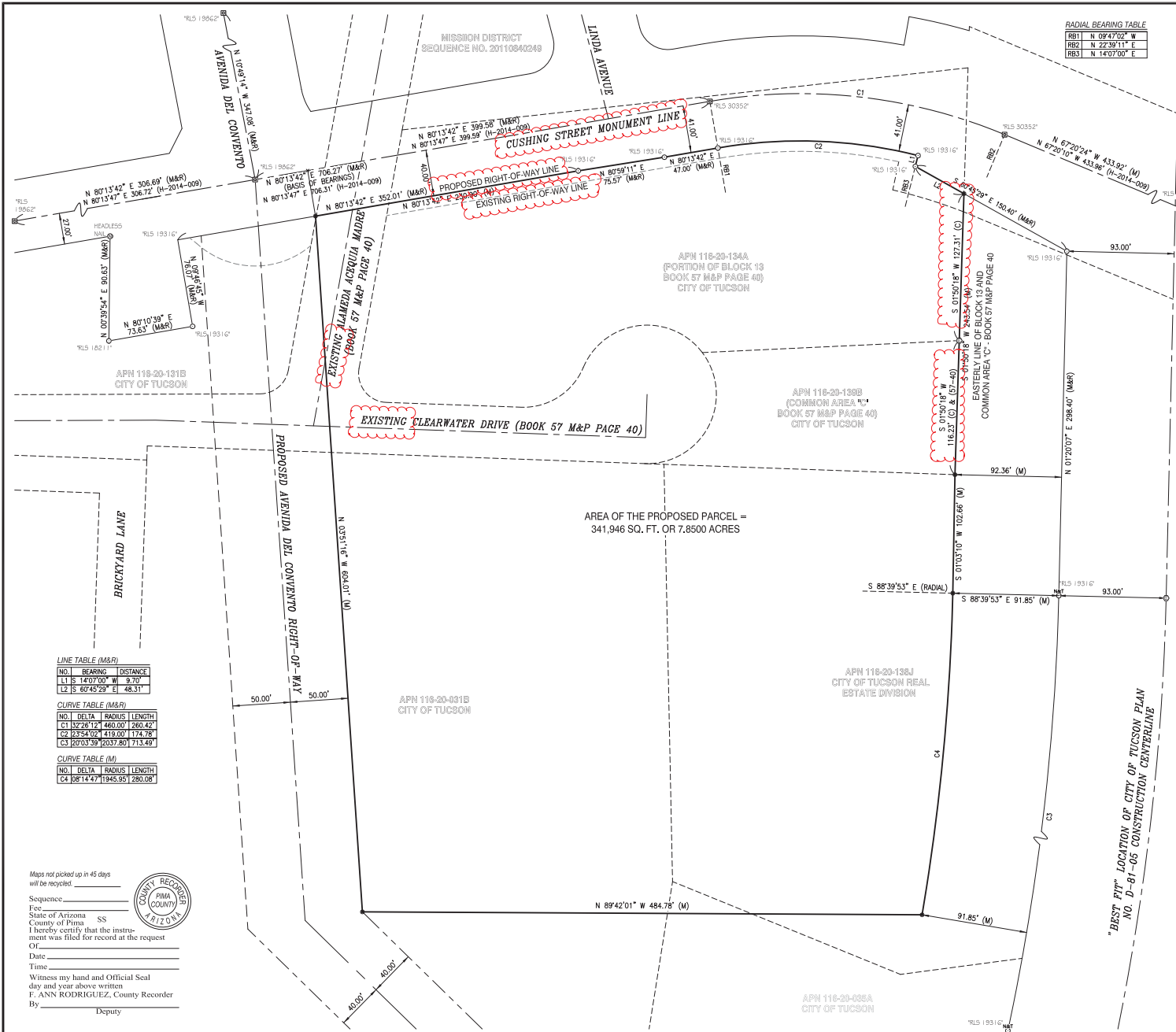

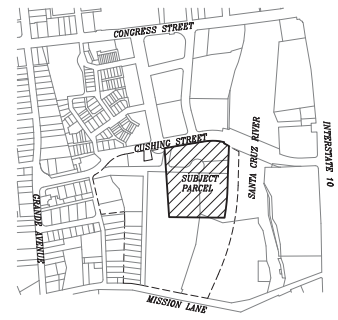

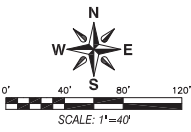


RADIAL BEARING TABLE
