I. A new Section 9.3 is added to the Request for Proposals:

- 9.3. <u>Protests.</u> Any Vendor may protest this RFQ, the proposed award of an Agreement, or the actual award of an Agreement. All protests will be considered in accordance with Article IX, Sec. 28-75 to 28-90 of the District Procurement Code, which can be found at www.rionuevo.org/procurement/.
- II. In response to inquiries received to date, Exhibit A Project Scope is amended as follows:
 - (1) In the first bullet point, a foldable aluminum ice floor system is specified. The District will consider alternative forms of piping, but foldable aluminum is the preferred system.
 - (2) In the first bullet point, a cooling connection system compatible with a 100-ton chiller is specified. The District/City of Tucson intends to provide a nominal 200-ton chiller (equal to approx. 100 real tons minimum), capable of achieving low temperatures in the secondary refrigerant of not higher than 5 degrees Fahrenheit.
- III. Item 12 in the Proposer Questionnaire and Affidavit (Section III of the RFP) requests the Proposer's Arizona Corporation Commission ("ACC") file number. Any out-of-state entity not currently registered with the ACC is required to register, and provide its ACC file number, before the District can enter into an agreement with such Proposer.
- * In the event that a Vendor cannot be selected based solely on Proposals submitted, oral interviews may be conducted at the District's sole discretion.
