successful program, at a time when the City's officer count is still dramatically below budget. Merchant feedback has been 100% positive and the statistics show a resulting dramatic decrease in criminal activity. The program begins as early as 7AM and stops at 10:30PM. After meeting with the Chief and senior staff along with area merchants it appears wise to extend the late-night hours longer to address the bar issues and provide officer visibility for people leaving concerts and events. The board will discuss an increase in the off-duty budget and the purchase of two side-by-side ATV type vehicles to be utilized downtown at a cost of about \$35,000 each.
